**Withdrawing Nominations**

Nominations cannot be withdrawn after 12:00pm (AWST) on 14/01/2019.

**Candidate Resume**

If a ballot is required, candidates may submit a resume to be included with ballot material. Only statements which comply with the Rules and are received by the Returning Officer by 12:00pm (AWST) on 21/01/2019 can be accepted.

Resumes are to be no more than 300 words, preferably in MS word format and must be submitted to the Returning Officer no later than 21/01/2019 (AWST).

**Voting Period**

The ballot, if required, will open on 04/02/2019 and close at 10:00am (AWST) on 18/03/2019.

**Scrutineers**

The appointment of scrutineers opens 04/02/2019 and closes 10:00am (AWST) on 18/03/2019.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
