QUALIFICATIONS

Nominations shall be in writing on the approved form, signed by at least two (2) financial members of the Institute and by the candidate who shall signify his/her consent to the nomination.

Candidates and nominators must be financial members of the Institute as at Monday 27 November 2017.

No financial member may nominate more than one candidate for each position.

Candidates for all positions must have been financial members of the Institute for the preceding two years.

Candidates for the position of Secretary must have knowledge of the Industries covered by the District and of applicable industrial legislation (Rule 9).

Candidates may nominate for more than one position, but may only be elected to one position.

Candidates may complete a resume not exceeding 300 words, in the form of a Statutory Declaration in Support of Candidature, details from which will be included in a Candidate Information Sheet which, if the election is contested, will accompany voting material when it is posted.

LODGEMENT OF NOMINATION MATERIAL

Lodgement of a correctly completed Nomination form and Statutory Declaration in Support of Candidature form, by the specified time, is the responsibility of the candidate.

and must be received by the returning officer no later than Noon, Friday 15 December 2017.

Any defect in a nomination or Statutory Declaration in Support of Candidature must be rectified by the candidate prior to the close of nominations at Noon Friday 15 December 2017. A candidate may only withdraw his/her nomination in writing so as to be received by the Returning Officer prior to the close of nominations.

VOTING

If the election is contested, a postal ballot will be conducted to close at Noon, Thursday 18 January 2018. All members of the Australian Institute of Marine and Power Engineers, NSW District, financial as at Monday 27 November 2017 and entitled to vote will be sent a ballot paper by Friday 22 December 2017.

The method of voting to be observed for this election will be "First Past The Post".
