## Candidate Statements

Each candidate may submit a candidate statement, **not exceeding three hundred (300) words**, for the inclusion with the ballot material. The candidate statement shall be in **Microsoft word format** and forwarded to the Returning Officer, no later than the closing date for Nominations.

Only statements which comply with the Rules and are received by the Returning Officer by 5:00pm (Australian Eastern Daylight Time (AEDT)) on 11/10/2024 can be accepted.

## Scrutineer Appointment

Any candidate may appoint a member who is not a candidate for election to be a scrutineer on the candidate's behalf. Such a scrutineer shall be appointed only with the scrutineer's consent in writing which shall be given to the Returning Officer not later than the closing time for the return of ballot papers. The appointment of scrutineers opens on 30/08/2024 and closes 10:00am Australian Eastern Daylight Time (AEDT) on 13/12/2024.
