(to be elected from the Vice Presidents)

Nominations which must be in writing and comply with the registered rules of the Organisation, may be made at any time from **27/05/2026**. Additional forms are available from the Returning Officer.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations for stage 1, must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 10:00am (Australian Central Standard Time (ACST)) on **10/06/2026 at the Council Meeting** at the Institute Chambers 22 Divett St. Port Adelaide SA 5015.

How to lodge nominations, nominations must be lodged via the following method(s):

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to IEBnominations@aec.gov.au

In-person: At the Federal Council Meeting on 10/06/2026 at the Institute Chambers 22 Divett St. Port Adelaide SA 5015.

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call to enquire about the status of your nomination.

Voting Period

The Attendance ballot for Stage 1, if required, will open and close as soon as practicable at the Council Meeting on 10/06/2026.

Nominations for Stage 2 will open soon after the election for Stage 1 is complete at the Council Meeting on 10/06/2026.

The attendance ballot for stage 2 (if required), will open and close as soon as practicable at the Council Meeting on 10/06/2026 and after the election for stage 1 is complete.

Scrutineers

The appointment of scrutineers closes at 10:00am (ACST) on 10/06/2026. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
