Scheduled Election

Fair Work (Registered Organisations) Act 2009

Nominations are called for:

Branch Secretary (1)

Nominations, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from 25/05/2020.

Nomination forms are available on request from the Returning Officer or from the Organisation.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 12:00pm Australian Eastern Standard Time (AEST) **on** 06/07/2020.

Note: According to rule 33 b (iv), the nominee and the nominator must be financial members. Further, rule 40(v) requires that Branch Secretary shall reside within the boundaries of the Branch. Further as per Rule 40(vi) a candidate for the position of Branch Secretary shall have been a financial member of the Institute for the two (2) years prior to their nomination. Further, rule 40(vii) requires the Branch Secretary shall have practical knowledge and experience of at least one of the Industries covered by the Institute.

Withdrawing Nominations

Nominations cannot be withdrawn after 12:00pm Australian Eastern Standard Time (AEST) on 06/07/2020.

Candidate Statements

Under Rule 33B (xv) of the Organisation, candidates may submit a resume not exceeding 300 words, for inclusion with the ballot paper. The resumes must be submitted not later than 12:00pm Australian Eastern Standard Time (AEST) on 13/07/2020. Resume should be submitted in Word document format and emailed to nswelections@aec.gov.au. Note that, emails greater than 6 MB may not be accepted by the AEC's firewall.

Voting Period

The ballot, if required, will open on 10/08/2020 and close at 10:00am Australian Eastern Standard Time (AEST) on 21/09/2020.

Scrutineers

According to Rule 33B (x) of the Organisation, the Returning Officer is to be informed about the appointment of the scrutineer in writing before the close of ballot period.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
