Note: According to rule 33 b (iv), the nominee and the nominator must be financial members.

Nominations cannot be withdrawn after 12:00pm Australian Eastern Standard Time (AEST) on 10/07/2020.

Candidate Statements

Under Rule 33B (xv) of the Organisation, candidates may submit a resume not exceeding 300 words, for inclusion with the ballot paper. The resumes must be submitted not later than 12:00pm Australian Eastern Standard Time (AEST) on 17/07/2020. Resume should be submitted in Word document format and emailed to nswelections@aec.gov.au. Note that, emails greater than 6 MB may not be accepted by the AEC's firewall.

Voting Period

The ballot, if required, will open on 14/08/2020 and close at 10:00am Australian Eastern Standard Time (AEST) on 25/09/2020.

Scrutineers

According to Rule 33B (x) of the Organisation, the Returning Officer is to be informed about the appointment of the scrutineer in writing before the close of ballot period.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
