This must be finalised one week BEFORE  commencement date of class as places in this course are limited, and are allocated upon receipt of payment.

- Participants are required to wear enclosed shoes and appropriate clothing. A list of what to bring for each session will be provided at time of confirmation of place.
- Participants are required to complete a Participant Screening form and hand back in on the first day of class. This document  will be sent out at the time of confirmation of enrolment.
